

PDI Warranty Policy

All PDI products carry a limited warranty to cover products materials and workmanship for a limited time period. Under specific circumstances such as product modification, incorrect application, installed on racing vehicles or misused and damaged in accidents, these issues can void the product warranty. Rugged – Wheel Spacers

Rugged ATV/UTV Parts warrants its Wheel Spacers to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. If it's over six months from date of purchase but within the 1-year period there may be a replacement fee subject to the part. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged - Performance Axles

Rugged Performance Axles (excluding boots & clamps) are warrantied to the original purchaser for a period of (1) year from the date of purchase against manufacturing defect only. Demon Powersports must be contacted immediately in case of the defective product received and not attempt to install or use the product. Demon Powersports warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. A torn boot is not covered under warranty. In all cases, the purchaser must provide a copy of the invoice, proof of breakage, and any other relevant information requested by Demon Powersports. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged – Propeller Shaft

Rugged ATV/UTV Parts warrants its propeller shaft Joint to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged – Electric Power Steering Kit

Rugged ATV/UTV Parts warrants its Power steering kit to the original purchaser for 1 year from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. If it's over six months from date of purchase but within the 1-year period, there may be a replacement fee subject to the part. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged - Wheel Bearings

Rugged ATV/UTV Parts warrants its Wheel bearings to the original purchaser for 3 months from the date of purchase against manufacturing defects in workmanship only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. If it's over 1 month from date of purchase but within the 3 months period, there may be a replacement fee subject to the part. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged Boot Kits

Rugged Parts warrants its Boot kits to the original purchaser for 1 month from the date of purchase against manufacturing defects in workmanship only. All the failures like wrong size, torn boot, broken clamps must be reported before installing. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged - U-Joints

Rugged ATV/UTV Parts warrants its U joints to the original purchaser for 1 years from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation or alteration. Rugged ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.

Rugged - Transmission Gears

Rugged ATV/UTV Parts warrants its U joints to the original purchaser for 2 years from the date of purchase against manufacturing defects in workmanship and material only. Rugged ATV/UTV Parts warranty does not apply to failure resulting from misuse, negligence, accident, improper application, improper installation, or alteration. Demon ATV/UTV parts does not cover the cost for removal and reinstallation of any kind.
